Discussion on Teton Pass Closure.

MAyor Manwaring discussed the recent closure to Teton Pass and the increased traffic through the valley. Some residents have asked about a temporary traffic light but it was discussed that they will wait for more information from Idaho Roads before making a decision. It is estimated that the pass may be open sooner than expected and the city wants to wait for more information from other road departments.
